- 2. The Army National Guard (ARNG) is seeking applications from highly qualified Majors to fill two critical positions at Redstone Arsenal, Alabama. The positions available are the Logistics Staff Officer and the Senior Logistics Analyst, both with an anticipated start date of **1 September 2024.**
- 3. Waivers and exceptions. Request for waivers or exceptions to these requirements must be approved by ARNG-HRH. Requests for exceptions are processed by ARNG-HCM to ARNG-HRH.

4. Eligibility.

- a. Current T10 AGR, T10 ADOS, Title 32 (T32) AGR, and Traditional (M-Day) Officers in the rank of Major.
- b. Applicants pending promotion must have Federal Recognition approved prior to accessing into the T10 AGR program.
 - c. New hires will have a minimum of eight years commissioned services.
 - d. New hires will have a minimum of four years ARNG service.
- e. New hires that cannot qualify for a 20-year Active Federal Service retirement require DARNG approval.

- f. New hires must have a minimum of 12 months of successful company command, except for those who Army doctrine has designated as "staff centric" and are not expected to hold company command experience. Therefore, those officers must have 12 months experience in one of the key developmental positions listed for their branch.
- g. Majors with five years time in grade require completion of Intermediate Level Education Common Core (ILE-CC) or equivalent.
- h. Majors with four years time in grade must be enrolled in ILE-CC (or equivalent) at the time of application submissions.
- 5. Exemplary Conduct Certification Screening. All candidates who apply undergo screening before final selection is made.
- 6. Brief Duty Descriptions:
- a. **Logistics Staff Officer:** Serve as Army National Guard Advisor to AMC and to the ARNG Assistant Deputy Commanding General (ADCG), AMC Mission Support Team. Works with AMC Major Subordinate Commands (MSCs) to develop training opportunities, utilizing real world missions/requirements for National Guard units to gain skills in core competencies and build unit readiness. Also manages executive officer duties for the ADCG, and serves as the lead Sustainment Advisory Council coordinator for AMC, in synch with the ARNG G5.
- b. **Senior Logistics Analyst:** Serve as Army National Guard Advisor to AMC and to the ARNG Assistant Deputy Commanding General (ADCG), AMC Mission Support Team. Provides technical expertise to ARNG equities across the ARNG enterprise. Monitors policy, procedures and technical data output from ARNG staff and ensures understanding within AMC HQ. Equities could include but are not limited to, GCSS-A expertise, understanding of ZPARK, ORILS, RCF and other supply and maintenance transactions.

 - a. Applicants must meet AGR eligibility requirements IAW AR 135-18
 - b. Grade: O4
 - c. Branch Requirement: 90A
